Active BORON™ 6% B is a foliar-applied boron fertilizer solution that corrects micronutrient deficiencies that can reduce crop yields.

DIRECTIONS FOR USE: READ ENTIRE LABEL BEFORE USE.

Apply at the rate of 1 – 2.5 L / 1 ha (0.4 – 1 L / acre) with sufficient water for thorough coverage. Use a minimum of 250 L of water / 1 ha (100 L / acre). **Berries and grapes:** blueberry, raspberry, strawberry, grape, apply: 1.25 L / ha (0.5L / acre). **Fruit trees:** apple, pear, apricot, peach, plum, cherry: apply 1.25 L / ha (0.5L/acre). **Nut trees:** almond, hazelnuts, walnut: apply 2.5 L / ha (1 L / acre). **Vegetables:** broccoli, cabbage, carrot, cauliflower, celery, lettuce, parsnip, radish, spinach, sweet corn, table beets, tomato, turnip: apply 1 L / ha (0.4 L / acre). **Field crops:** canola, soybean, corn, alfalfa: apply 1 L / ha (0.4 L / acre).
