DIRECTIONS FOR USE: READ THE ENTIRE LABEL BEFORE USING THIS PRODUCT. SHAKE WELL BEFORE USING. Apply as a seed nutrient dressing to wheat, canola or barley seeds at the rate of 4 ml / kg of seed. Seed coating can be done simultaneously with Active Prime™ and compatible agrochemicals. If using Active PRIME™ without additional agrochemicals, dilute with water (1:1 ratio) to ensure uniform coverage of seeds.

- Calibrate equipment to release the required amount of Active Prime™ and other agrochemicals based on seed flow rate.
- Thoroughly mix seeds with the Active Prime™ (and other agrochemicals) mixture. A coloring additive allows a visual check to ensure all seeds are uniformly coated.
- Allow treated seeds to air dry for 5-10 min before seeding.

Application rates exceeding recommended rates can negatively affect seed germination. Always follow label directions.

COMPATIBILITY: This product is compatible with most fertilizers, and pesticides. If compatibility is uncertain, conduct a jar test prior to use.
